Milan, January 29, 2024 – **Italian Design Brands S.p.A.**, diversified industrial group among the Italian leaders in design, lighting, and furniture ("**IDB**" or the "**Company**") – LEI code: 8156009C6B018FE67A34, informs to have purchased on Euronext Milan, in the period between **January 22, 2024** and **January 26, 2024**, no. **8,898** ordinary shares (equal to 0.033% of the share capital) at the average unit price of EUR **9.4369** for a total amount equal to EUR **83,969.81**

Such transactions were carried out as part of the authorization to the purchase of treasury shares approved by the Shareholders' Meeting of 16 November 2023, carrying out the treasury shares' purchase program started on December 18, 2023 (already object of disclosure also pursuant to art.144 bis of the CONSOB Regulation 11971/99 and to art. 132 of D.Lgs. n. 58/98).

The purchases have been carried out through the authorized intermediary Equita SIM S.p.A. - LEI code 815600CF5C54AA9C0721.
